**Needle recommendation:**

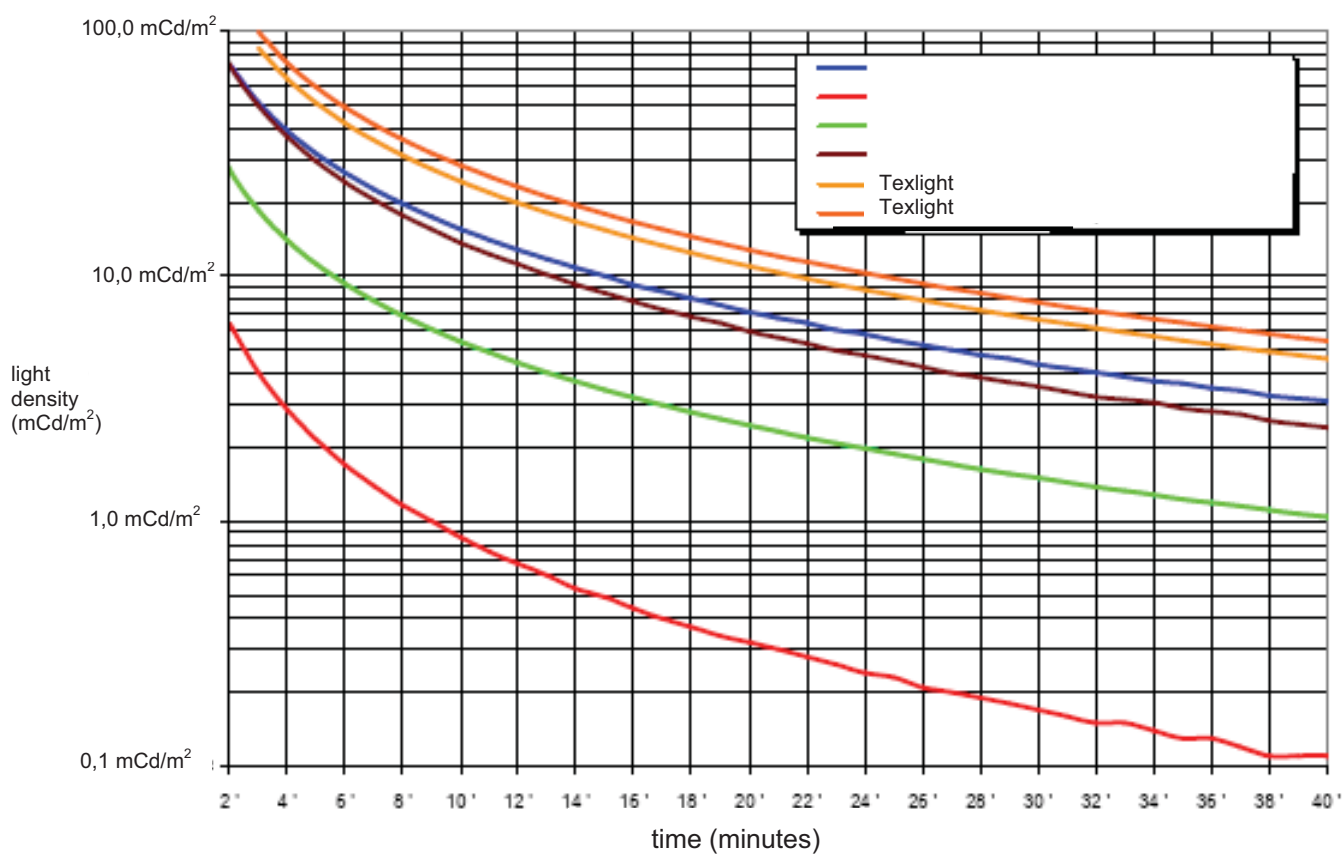
We suggest to use needle size Nm 70-80, system DBxK5 for embroidery.

For your information:

The candela is the luminous intensity emitted by a light source in a particular direction; such source emitting a monochromatic radiation with a frequency of  $540 \cdot 10^{12}$  Hertz, whose radiant intensity in such direction is  $(1/683)$  Watt divided by the steradian.
