Robust compliance is the cornerstone of our EHS program. We meet or exceed all applicable EHS legal regulations and company standards. Our managers, employees, contractors, and key partners have a responsibility to comply with all applicable EHS requirements. We follow established policies, procedures, and share best practices to create safe and compliant workplaces and environmentally responsible operations.

Employee safety is fundamental for our mission. We encourage and empower our employees to identify, understand and mitigate the safety risks associated with their roles. We promote our "speak-up" culture so employees report all potential and actual risks and incidents. Environment sustainability is our responsibility. We are committed to operate responsibly and we seek to reduce adverse environmental impacts from our operations. To manage our environmental risks, we pursue a path of continuous improvement — investigating, assessing, understanding and improving environmental aspects as well as impacts to manage waste and emissions to protect water, air and soil.

We hold ourselves accountable through verification and frequent reporting of our performance. We treat violations of the EHS Policy and our management system seriously and take appropriate action in response.
